MEMBER RELEASE, WAIVER, COVENANT NOT TO SUE, HOLD HARMLESS AND INDEMNIFICATION AGREEMENT

In consideration for being permitted to now and in the future enter the property of CORE Shooting, LLC, and CORE Shooting Center, LLC, (collectively, "CORE") both Florida limited liability companies, to use the facilities, amenities, equipment, real property, personal property and lodging located therein ("Property"), as well as to conduct or engage in Dangerous Activities on the Property, including, but not limited to, instruction in the use of firearms, use of the premises, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I, the undersigned Participant Member, individually and/or on behalf of my minor child/ward as applicable, (hereinafter collectively "I" or "me"), expressly agree to the terms of this **RELEASE, WAIVER, INDEMNIFICATION, HOLD HARMLESS, AND ASSUMPTION OF RISK AGREEMENT** (hereinafter the "Form"), and accept and assume any and all unknown risks existing at the Property, upon entrance into the Property, and in participation in any CORE program or related activity or event, including, but not limited to, unorganized practice, organized practice, training and instruction, and shooting competitions and events:

No Legal Restrictions: I hereby state that I am legally permitted to possess any firearm or ammunition I bring onto the Property; I am not subject to any injunction that would prevent me from possessing a firearm or ammunition; I have not been convicted of a felony; I am not under any legal disability or legal restriction that would prevent me from possessing a firearm or ammunition; and I am not under the influence of any drugs or alcohol which prevent me from reading and understanding this Form. I hereby acknowledge and agree I have read, understand and will at all times abide by all applicable State and Federal Regulations related to the use and possession of any firearm or ammunition in my possession while on the Property, and will fully abide by those rules and regulations. If any rules, laws, or regulations of any governmental entity governing my participation impose more stringent requirements upon me than the terms of this Form, then I agree to be bound by the more stringent requirements. This Form binds me and my executors, administrators, assignees or heirs. I certify that I am a citizen of good repute of the United States of America, that I am not a member of any organization or group having as one of its purposes the overthrow by force or violence against the Government of the United States of America or any of its political subdivisions, that I have never been convicted of a crime of violence, and that I will fulfill the obligations of good sportsmanship and good citizenship. (___ Init.)

Inspection / No Warranties by CORE: Before executing this Form and participating in activities at the Property, I acknowledge, understand and agree that I have had the opportunity to inspect the facilities, products and equipment to be used, to assure myself of their safe condition and have either done so or voluntarily chosen not to do so. I further agree that CORE is offering me the opportunity to inspect the facilities, products and equipment each time I enter CORE and/or participate in activities on the Property, to assure myself of their safe condition, and that if I fail to do so it is entirely and solely of my own volition. I understand, acknowledge and agree that neither CORE nor any of its subsidiaries, members, owners, directors, officers, managers, employees, agents, representatives, instructors, drivers, and customers (hereinafter collectively "Agents") makes any representation or warranty to the design, manufacture, maintenance, condition or fitness for any particular purpose of any of the facilities, products or equipment on the Property. I acknowledge, understand, and agree that the nature and condition of the Property is such that both known and unanticipated risks and hazards exist, which create or contribute to both known and unanticipated risks inherent on entering the Property and in engaging in or observing shooting or any other activities of any kind whatsoever thereon. I understand that such risks and hazards cannot be eliminated without compromising the essential qualities of CORE. I agree to personally examine any CORE equipment I utilize while on the Property to ensure it is in good working condition and functioning properly. I understand that CORE accepts no responsibility for any defect in equipment and that THERE IS NO WARRANTY OF MERCHANTABILITY OR WARRANTY FOR A PARTICULAR PURPOSE FOR ANY OF THE EQUIPMENT. THE USE OF ALL EQUIPMENT IS AT MY OWN RISK. I further acknowledge that prior to my application for membership, I had the right to review all policies, procedures and safety protocols in place by CORE. I am fully satisfied with the premises, facilities, procedures and protocols of CORE, and I assume all risks associated with my membership. (___ Init.)

Voluntary Application / Assumption of Risk: I hereby acknowledge, understand and agree that I have voluntarily applied to and expressly assume the risk of entering the Property, and/or to engage in and/or to observe, shooting events, training, and other activities thereon. I further acknowledge and understand that said "other activities" includes any and all activities of any kind whatsoever in which I can engage in or observe while on the Property, including, but not limited to, instruction in and the use of firearms and/or archery, discharge of firearms, firing of live ammunition, and taking part in CORE activities and events, whether sponsored by me, CORE, or any other person or entity. I ACKNOWLEDGE, UNDERSTAND AND AGREE THAT FIREARMS ARE DANGEROUS INSTRUMENTALITIES, AND THAT SHOOTING AND THE USE OF FIREARMS AND AMMUNITION MAY BE INHERENTLY DANGEROUS AND MAY CAUSE SERIOUS PHYSICAL OR EMOTIONAL INJURY, PARTIAL OR TOTAL LOSS OF EYESIGHT OR HEARING, PARALYSIS, PERMANENT DISABILITY, OR EVEN DEATH TO MYSELF OR OTHERS. I also understand that serious injury may occur from many causes and sources, including, but not limited to the following: being shot, whether by myself or others; inhalation, absorption or other harmful contact with lead, brass, gunpowder, cleaning solvents, and other contaminants; ricochets from firearms or other equipment that I am using or not using, but are in use on any range while I am also on the range; explosions from ammunition; and being struck by flying or falling objects. I knowingly accept all risks, known and unknown, and expressly and unequivocally fully release CORE and its Agents, as defined above, from any and all liability in connection therewith. (___ Init.)

Indemnification: In consideration of my participation in any and all CORE activities, if CORE is made a party by any person or entity to any lawsuit commenced against me THEN I HEREBY AGREE TO RELEASE, INDEMNIFY, HOLD HARMLESS, protect and defend CORE, and any of its Agents, and pay all expenses, costs and legal fees incurred or paid by CORE or such other parties in connection with the dispute. Such payment shall be made immediately upon demand. Should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws or the United States or of any State, including Florida, under any theory of law or equity, I agree to indemnify, save, and hold CORE and its Agents harmless from any and/or all damages, losses, claims, actions, fault, liabilities, costs, expenses, demands, lawsuits or proceedings of any kind or character, including, but not limited to, actions for attorneys' fees and expenses, the cost of any settlement or judgment made or rendered against CORE, (whether individually or jointly, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees, legal assistants' fees and costs prior to trial, at trial, and on appeal, and in any bankruptcy or creditor's reorganization proceedings, in addition to any other relief to which CORE may be legally or equitably entitled) which may be presented or initiated by any person or entity and which arise directly or indirectly from my participation in any activities at CORE, including but not limited to, unorganized practice, organized practice, training and instruction, and shooting competitions and events taking place on the Property; and any and all of my acts or omissions, whether resulting from the negligent acts or other fault, either active or passive, of CORE, of bystanders, participants, or guests, or from any other cause. I intend for this indemnification to and it shall include all expenses including attorney's fees irrespective of how any claims may be resolved, i.e., through litigation, mediation, arbitration, or any other

form either in or out of court. It is my intent that no claims of any person or entity through me or against me shall ever cause CORE to incur or suffer any expenses or damages whatsoever. (____ Init.)

Release: I acknowledge, understand and agree that there are serious risks and dangers involved in the activities at CORE, and having been properly warned of all said risks and dangers, I accept and assume all risks and dangers associated with activities in which I participate and/or observe, or which may otherwise occur, while on the Property, and on other properties used or owned by CORE. I hereby expressly release and discharge to the fullest extent permitted by law, CORE and its Agents, and property owners of all Property, both real and personal, used for activities at or through CORE, and their collective agents, operators and manufacturers of the equipment or products used while I am on any property or facility operated, owned or used by CORE and related activities, including transportation and any firearms that I may rent from CORE, or which may be loaned to me by CORE, as well as any ammunition I may purchase from CORE, and all other landowners, tenants, participants, and sponsors of any activity conducted by CORE, from all rights, claims, demands, damages, actions, and causes of action, of any nature whatsoever, including, but not limited to, all negligent acts by CORE, bystanders, participants, guests, or anyone else present during such acts, whether arising at law or in equity, which I may have or may hereafter have, against CORE by reason of any matter, cause, happening or thing while participating in any activity or thing at CORE, whether resulting from the negligence or other fault, either active or passive, of CORE, or from any other cause, from the date of my signature below until the end of time. The above release and hold harmless shall include, but not be limited to, the transportation of firearms to and from CORE's facilities, as well as the handling or use of firearms while participating in live-fire events on any of CORE's facilities. I further represent that the method I, or any guest of mine, shall employ in the transport of any firearms conforms to any applicable local, state and federal laws. (____ Init.)

Agreement Not To Sue: I hereby knowingly and intentionally release, waive, discharge and covenant agree never to institute any lawsuit or cause of action against CORE or its Agents, or to initiate or to assist in the prosecution of any claim for damages against CORE or its Agents which I may have by reason of injury to my person or property, or my death, arising from the activities covered by this Form, whether caused by the passive, active, or grossly negligent act or omission of CORE or its Agents, or from any other cause. I further agree that my family, next of kin, heirs, issue (born or unborn), executors, administrators, personal representatives, assignees, and/or anyone else claiming on my behalf (hereinafter collectively "Estate") shall not institute any lawsuit, cause of action, or claim for damages against CORE or its Agents, and my Estate shall not initiate or assist in the prosecution of any claim for damages against CORE or its Agents which I and/or my Estate may have by reason of injury to my person or property, or my death, arising from the activities covered by this Form, whether caused by the passive, active, or grossly negligent act or omission, of CORE, or from any other causes, and I hereby so instruct my Estate. Should any such lawsuit or cause of action be instituted against CORE or its Agents, I agree that CORE shall be entitled to recover from me, or my estate, or my trust, all attorneys' fees, expenses, costs, incurred in the defense of such lawsuit or cause of action, including any arising therefrom, whether or not such litigation is successful. I HEREBY ACKNOWLEDGE THAT I AM KNOWINGLY RELINQUISHING ANY AND ALL CLAIMS, INCLUDING CLAIMS WHOLLY OR PARTIALLY BASED UPON CORE'S OWN NEGLIGENCE, OR THAT OF ITS AGENTS. (____ Init.)

Range Rules and Instructions: I hereby represent and affirm that I, and any guest of mine, shall be knowledgeable of all firearms and/or ammunition that I, and any guest of mine will use while visiting the Property. Prior to entering the Property, I, and any guest of mine, shall read, understand, and comply with all posted and published rules and regulations as they relate to the use of the Property. I further acknowledge that I have been informed that basic firearms education courses are available to me and any guest of mine who may use the Property, and I warrant and represent that I will so inform any guest of mine of the availability of such courses. I further acknowledge that in the event that, I, or any guest of mine, engages in any activity without having requisite the knowledge, experience or ability to do so safe manner, I and/or my guest may be expelled from the Property and receive temporary and/or permanent loss of CORE range privileges. I acknowledge that CORE reserves the right to refuse access to CORE's facilities or remove any person(s) from CORE's facilities for any reason that could jeopardize the safety of any person, result in damage to CORE's property, or which could adversely affect the enjoyment of the CORE facilities of any member or guest, i.e., such person demonstrates unsafe firearm handling practices, a lack of proper training, possesses an unsafe firearm, becomes loud, boisterous or disruptive, or any other act or omission that is contrary to established criteria for operating a safe and efficient shooting range. (____ Init.)

Alcohol and Drugs: I affirm that I, and any guest of mine, will refrain from being under the influence of alcoholic beverages, illegal drugs or any prescription or over-the-counter drug which could conceivably have any impact on our ability to conduct ourselves in a safe manner, while I am on the CORE Property. I further understand that alcohol consumption before or while operating firearms or while otherwise participating in CORE events is prohibited by CORE. In the event any guest of mine is impaired in violation of this section, I hereby accept full responsibility for such guest, and I specifically indemnify and hold harmless CORE and its Agents for any and all liability or claims related in any manner to such guest, irrespective of whether I knew, or reasonably could have been expected to have known, of my guest's impairment. (____ Init.)

Guests: I accept full and unconditional responsibility for any guest of mine. I understand that if I object to this provision, I have the ability to fully protect myself by not inviting or sponsoring any guests. I fully release, indemnify and hold harmless the Released Parties for any and all liability or claims related in any manner to my guests, irrespective of whether I knew, or reasonably could have been expected to have known, that any guest would act in any manner generating any liability or claim. (____ Init.)

Ammunition: I affirm that the ammunition I will use on CORE facilities has been properly loaded, either by a licensed manufacturer or, if the ammunition has been hand loaded by me, that it was done so by following established criteria as contained in leading reloading manuals, and that such reloads meet or exceed all factory specifications. I hereby covenant that I MAY NOT USE ARMOR PIERCING, STEEL CORE, INCENDIARY or TRACER AMMUNITION, and that in the event I violate this prohibition, I shall be strictly liable (irrespective of fault) for any and all damages arising out of, or related in any manner to use of such ammunition, as well as being immediately removed from CORE facilities and having my membership automatically terminated without having the right to receive any refund. (____ Init.)

Photo, Audio and Visual Release: While utilizing CORE facilities, I acknowledge that my image will be captured by closed circuit TV and possibly by attendees or staff taking photos or videos. All such photos/images may be used for promotion, and I fully release my likeness to be used by CORE without further consent. (____ Init.)

Waiver of Rights: I HAVE CAREFULLY READ THIS FORM AND I UNDERSTAND EACH AND EVERY PROVISION SET FORTH ABOVE. I UNDERSTAND THAT BY MY SIGNATURE I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS AND IT IS MY INTENTION TO DO SO. I UNDERSTAND THAT BY SIGNING THIS FORM I AGREE NOT TO SUE CORE. I ACKNOWLEDGE THAT NO OTHER INDUCEMENT, ASSURANCE, OR GUARANTEE HAS BEEN MADE TO ME IN CONSIDERATION OF MY SIGNING THIS FORM, ORALLY OR IN WRITING AND SHALL THEREFORE NEVER CLAIM THAT I WAS FRAUDULENTLY INDUCED TO ENTER INTO THIS AGREEMENT. I SIGN THIS DOCUMENT VOLUNTARILY AND OF MY OWN FREE WILL.

I CERTAINLY HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND CORE AND/OR ITS AGENTS HAS THE RIGHT TO REFUSE TO LET MY CHILD PARTICIPATE IF I DO NOT SIGN THIS FORM.
